Purpose of the Ministry

The Premier serves as the President of the Executive Council (Cabinet) of the Government of British Columbia. The Office of the Premier assists the Premier in overseeing and leading the government as a whole. In addition, it supports the Cabinet decision-making process. As a central agency, the Office facilitates effective policy coordination across the public service and ensures a strategic and corporate level approach is undertaken on the development and implementation of key priorities. The Premier is advised by the Deputy Minister to the Premier, Cabinet Secretary and Head of the Public Service on matters of public policy, and management and operational issues.

The Office:

- Articulates government's goals, commitments and priorities through ministry mandate letters, and works with ministries and Crown agencies to ensure communication of those goals, commitments and priorities and to track and monitor their implementation;
- Leads the public service and, with the Deputy Ministers' Council, commits to being a top employer that maintains and enhances public trust and confidence in our work, as set out in the new Corporate Plan <u>Where Ideas Work</u> and reflected in the focus on innovation and integrity;
- Provides support for the operations and decision-making processes of Cabinet and its committees; and
- Works directly with the federal government and with all ministries and Crown agencies to ensure that relations with the federal, provincial, territorial and international governments advance British Columbia's interests.

Strategic Direction

The Government of British Columbia is putting people at the heart of decision-making by working to make life more affordable, improve the services people count on, and build a strong, sustainable economy that works for everyone.

Over the past year, significant government investments in areas including housing, child care and the elimination of fees, such as Medical Service Premiums, have contributed to making life more affordable for British Columbians today and into the future. Ministries are engaged in ongoing work to improve the availability of services citizens rely on including those related to primary medical care, education and training, transportation, the opioid crisis and poverty.

A strong economy that works for all regions of B.C. is diversified, resilient and improves the standard of living for people across the province. With that in mind, government is focusing on sustainable economic growth that strengthens our natural resource sector, continues the development of the emerging economy, supports small business and uses innovation and technology to solve B.C. problems. A key priority in 2019/20 and beyond will be driving economic growth with cleaner energy and fewer emissions. At the same time, ministries continue to build prudence into budgets and plan for challenges.

Underpinning the work of all ministries are two shared commitments: reconciliation with Indigenous peoples and consideration of how diverse groups of British Columbians may experience our policies, programs and initiatives. As part of these commitments, ministries are working to implement the United Nations Declaration on the Rights of Indigenous Peoples, the Truth and Reconciliation Commission of Canada's Calls to Action, and Gender-Based Analysis+ policy and budgeting.

- Determine the priority sequence for the implementation of government goals, commitments and priorities, aligned with government's fiscal and delivery capacity;
- Monitor progress on implementing government's goals and priorities.

- Strengthen partnerships with other provinces through bilateral and multilateral co-operation on shared priorities discussed at the Council of the Federation, Western Premiers' Conference and other Premiers' meetings.
- Positively influence the policies and programs of other governments that affect the interests of British Columbia through enhanced economic, cultural and diplomatic ties, programs and advocacy.
- Maintain regional leadership and establish shared economic and environmental priorities through the Pacific Coast Collaborative, British Columbia's participation in the Pacific NorthWest Economic Region (PNWER) and other opportunities as they arise.
- Lead and coordinate government ceremonial, protocol and diplomatic activities that are key to advancing B.C.'s priorities.
- Advocate for and defend B.C.'s interests in the context of rising American protectionism and work in partnership with the Canadian federal government, other provincial and territorial governments, and likeminded U.S. state governments.
