Introductory Note — A Year of Transition

The Government of British Columbia and its ministries are committed to reporting on performance. The *Budget Transparency and Accountability Act* (BTAA), as amended in August 2001, provides the legislative framework for a regular cycle of planning, reporting and accountability. Under the BTAA, ministries are responsible for producing three-year service plans (previously called performance plans), which are updated yearly, and annual service plan reports (formerly called performance reports). The amended BTAA takes effect beginning with the 2002/03 fiscal year. The first three-year service plans, covering the period 2002/03 to 2004/05, were released with the provincial budget on February 19, 2002.

This annual report relates to the previous fiscal year, covering April 1, 2001, to March 31, 2002. This was a transition year, with a new government sworn into office on June 5, 2001. On that day, there was an extensive reorganization of ministries, which were given significant new policy direction and tasked with the responsibility for implementing the government's *New Era* commitments. Later in the year, ministries proceeded through the core services review, which refined the mandates of ministries and identified the strategic shifts required to move government toward its long-term objectives.

This report provides an update on all that activity and also provides a report on performance, approaching the model provided by the BTAA as closely as is possible in the circumstances. An annual report would normally relate back to a preceding plan and report on the results achieved compared with the intentions outlined in that plan. In this case, the preceding plan was produced before the adoption of the significant changes outlined above, and as noted, this ministry has been significantly reorganized, and policies and priorities have changed. This limits the extent to which performance information as described in the previous plan is useful.

Consequently, this report sets out the ministry's redefined role and the services it provides, and — within the context of its goals and objectives as they evolved through the year — describes the achievements of the ministry and the performance targets being used to measure success.

Accountability Statement

The 2001/02 Ministry of Competition, Science and Enterprise Annual Report was prepared under my direction and I am accountable for the results of the Ministry since June 5, 2001. This report describes progress made in this first year on the government's *New Era* commitments, which are to be addressed by May 17, 2005.

Ministry of Competition, Science and Enterprise



On June 5, 2001, a new government took office in British Columbia. The Ministry of Competition, Science and Enterprise was created to implement key elements of the government's *New Era* commitments, aimed at revitalizing the economy and the business environment in British Columbia. We have made significant progress in this task.

In 2001/02, the ministry focused on ending business subsidies and deregulating, ensuring British Columbia was open for business, and acting as an advocate for business inside and outside of government. The new ministry has

four Core Business Areas: removing barriers to business; providing economic policy and strategic advice; marketing and investment; and encouraging innovation and the development and transfer of new knowledge.

In 2001/02 the Ministry of Competition, Science and Enterprise began eliminating business subsidies, and reviewing fees and licences. These two projects will be complete early in 2002/03.

The Ministry fulfilled a commitment of the Premier by bringing the province into compliance with the Agreement on Internal Trade on March 31, 2002. We have taken steps to fulfil another commitment of the Premier by introducing competition and choice for investors in labour sponsored venture capital funds.

The Northern Development Commission was eliminated after a review found that it was not the most effective vehicle to address issues of importance to the North. The government's northern caucus is the most effective vehicle and was asked to aggressively pursue a northern agenda and to ensure issues and priorities of the North receive the full attention they need and deserve. In addition, the Job Protection Commission has been wound down, with no new clients after February 2002. Also in April 2002, the Ministry successfully concluded the sale of Skeena Cellulose Inc. to NWBC Timber and Pulp Ltd., completing a promised transfer back to the private sector.

We have continued work on the planned expansion of the Vancouver Convention and Exhibition Centre. We also provided secretariat support for the new Premier's Technology Council during its formation and its work on bridging the digital divide.

Through the Minister of State for Deregulation's office, we have taken significant steps towards reducing regulatory burden by establishing a baseline count for government and ensuring all ministries have a three-year service plan to cut regulatory requirements by one-third. Two deregulation statutes were introduced in the spring 2002 legislative session.



We are pleased with the steps the Ministry has taken this year, and plan to improve on this progress in the coming years.

We are pleased to present the details of our activities in this annual report for the fiscal year 2001/02.

Year-at-a-Glance Highlights

Performance plans for provincial government ministries and agencies for 2001-2004 were produced in April 2001. The new Ministry of Competition, Science and Enterprise was created on June 5, 2001. The Ministry includes most of the former Ministry of Employment and Investment (except for electricity policy functions, which were moved to the Ministry of Energy and Mines). Organizational units responsible for science and technology, small business, tourism and film were brought into the new Ministry.

Following the creation of the Ministry, an intense, focused period of review was undertaken to consider the policy and operational roles of the organization, critically review the role, if any, for government involvement in these existing functions and the need for government attention to any new functions. The results were presented to the government's core review and deregulation task force. The strategic shifts approved by the task force are set out on page 4 of this report.

In implementing our strategic shifts and meeting budget targets set by the government, the Ministry undertook a significant reorganization. As noted in our report on resources, full time equivalent (FTE) staff were 305 in the newly formed Ministry at June 5, 2001. By the end of 2001/02, this number had been reduced to 253 FTEs.

Throughout the core review and budget processes, the Ministry focused on meeting the government commitments set out in the *New Era* document. Several critical priorities, such as eliminating government subsidies, were initiated and essentially completed before the end of 2001/02. A complete report on the Ministry's *New Era* commitments begins on page 6 of this report.

Ministry Role and Services

Strategic Shifts

The core review process led the new Ministry of Competition, Science and Enterprise to some fundamental strategic shifts:

- From an emphasis on socially focused economic policy to an emphasis on business-focused economic policy;
- From programs distributing financial assistance and subsidies to a process of ending subsidies and reducing regulation across government;
- From a government role as financier, builder and promoter, to a role marketing British Columbia as ‘open for business’; and
- From a role as government’s voice to business to a role as a voice for entrepreneurs and business to government.

Following the creation of the Ministry of Competition, Science and Enterprise in June 2001, the new Ministry defined its goals, mission and values:

The new Ministry of Competition, Science and Enterprise is focused on activities that directly support the government’s first strategic goal of ‘a strong and vibrant provincial economy.’ In supporting that goal, the Ministry also directly and indirectly supports the government’s other goals of ‘building a supportive social infrastructure’ and ‘safe, healthy communities and a sustainable environment.’

The Ministry endorses and implements the government’s management theme and works in an innovative, results-oriented and accountable way.

The Ministry’s mission is focused on three areas:

COMPETITION

Ensure British Columbia has the most attractive investment and business climate in North America.

SCIENCE

Encourage a culture of innovation and the development and transfer of new knowledge benefiting individuals, businesses and communities.

ENTERPRISE

Promote economic growth by aggressively pursuing increased marketing of British Columbia that results in the growth of investment and trade.

The Ministry of Competition, Science and Enterprise is focused on establishing and expanding partnerships with entrepreneurs, businesses and organizations throughout British Columbia in order to build a strong private-sector-driven economy; fostering an innovation culture for science and technology; and developing national and international investment and trade relationships.

We are advocates within government for entrepreneurs and business, and marketers of our competitive economic climate to national and international investors in the global marketplace.

Our Ministry believes in customer service and we will be a results-driven organization that measures performance at both the individual and global level.

THE MINISTRY HAS FOUR CORE BUSINESS AREAS

- Removing barriers to business;
- Providing economic policy and strategic advice;
- Marketing and investment; and
- Encouraging innovation and the development and transfer of new knowledge.

The goals, objectives and strategies related to these core business areas will be reviewed in the Performance Reporting section of this report.

Performance Reporting

The Ministry of Competition, Science and Enterprise has three main goals: establishing a competitive investment climate; promoting economic growth; and encouraging innovation, science and technology transfer.

The Ministry made progress on a number of performance targets identified in the 2002/03 – 2004/05 Service Plan during the 2001/02 fiscal year. In 2001/02 the Ministry:

- Made significant progress on its task of eliminating business subsidies. Final subsidies will be completely eliminated in July 2002;
- Established policies, standards and benchmarks for achieving the government's regulatory reduction target in three years;
- Achieved full and complete compliance with the Agreement on Internal Trade;
- Worked with the Premier's Office to establish the Premier's Technology Council, and provided support for the Council's quarterly reports; and
- Reviewed the policy for fees and licences.

A number of the performance measures established in the 2001/02 – 2003/04 performance plans of the Ministries of Employment and Investment, and Small Business, Tourism and Culture of the former government are not included in this Annual Report.

With the government restructuring of June 5, 2001 a number of responsibilities of the former ministries were transferred to other ministries or agencies of government. For example, responsibility for energy development was transferred to the Ministry of Energy and Mines.

Through the Core Services Review a number of other responsibilities were no longer deemed to be central to the goals of the Ministry and were eliminated. In addition, several Ministry programs were eliminated as a result of the governmentwide business subsidy review. For example, the Job Protection Commission function, loan guarantees and fiscal agency loans under the *Financial Administration Act*, the Small Business Incentive Program, First Job in Science and Technology Program, Technology BC Program and Technology Assistance Program were eliminated.
